The contracts were awarded to the lowest and most responsive bidders. The contracts were originally issued July 1, 2018, with three optional one - year renewals. Contractors will deliver the products to participants of the Child Nutrition programs in all seven regions of the state. Payment will be made directly to the contracted distributor by the local organizations.
