## INTRODUCTION

The Mississippi Department of Education (MDE) is committed to providing **essential technical guidance and support mechanisms** to assist districts during the time of extended school building closure as a result of COVID-19. The MDE recognizes and appreciates that districts are taking different approaches depending on their local capacity and infrastructure during this building closure. The State Board of Education (SBE) has provided **flexibility within existing laws and policies** regarding instructional time, graduation requirements, attendance, assessment and accountability.

In accordance with Governor Tate Reeves' **Executive Order 1476**, school districts shall operate with essential personnel to offer distance learning or other instructional means necessary for students to achieve completion of grade-level essential instruction for the 2019-2020 academic school year. Additionally, school districts shall submit to the SBE plans for summer learning and enrichment measures necessary to (a) mitigate disruption from the Spring 2020 school closure due to COVID-19 and (b) to enhance learning in preparation for the 2020-21 academic school year. Per **Executive Order 1476**, summer learning and enrichment measures are to be provided to all students in all schools.

The District Learning-at-Home and Summer Enrichment Plan is designed to ensure districts are taking deliberate and thoughtful actions to facilitate and individualize continued student learning and progress monitoring during closure.

Taking a traditional school environment online is not a simple task – nor is it one that should be attempted without serious consideration of the practicality and risk.

The MDE is not directing districts that they must transition to delivery of all content online, as we recognize that online access and remote support for rural students and students with disabilities will certainly pose equity issues across the state. Districts need to consider how they can help facilitate continued learning within homes across the state – either through online opportunities, by making grade-level instructional packets, Family Guides for Student Success, or other resources available for pick-up at school or various locations within the district, or through a combination of delivery systems.

**Grade Band: K-8**

In accordance with [Executive Order 1476](#), describe how the district will provide students with feedback/grades on assignments completed during the extended school building closure and during summer learning and enrichment programs.

**K-2nd:** Teachers work with parents to develop individualized learning plans based on the student’s learning needs and digital access capabilities. Work can be returned electronically, by mail, or by dropoff at the school. Teachers remain in contact with parents on a weekly or biweekly basis to give feedback and keep students on their learning track.

**3rd-5th:** Feedback on assignments during building closure is sent through Google Classroom, Remind 101, and phone calls to students’ parents/guardians. Grades are entered

into SAM. If there are concerns regarding grades, contact with the students' parents/guardians are made. During summer school, feedback and progress on standards are given through weekly progress checks that are given to students' parents/guardians.

**6th-8th:** Currently, only students that were failing at the end of T3 are receiving grades for work completed. These students received hard copies of assignments last month and again this month. These grades will be entered under T3 grades. In addition, all students are receiving assignments in the core subjects and some electives in Google Classroom and iReady on their individual pathway.

**9th-12th:** Each teacher contacted students to determine how students would like to receive assignments (online or paper). Teachers maintained contact with students and parents regarding assignments and grading. Teachers communicated with students that the failure to complete assignments would not affect the students negatively and that all assignments that were completed would result in the award of extra credit. The grade the student received for the 3rd nine weeks would be the same grade they received for the 4th nine weeks. The only exception to this would be those classes that began at the end of March (4th 9 weeks classes). The fourth nine weeks classes assignments were graded for credit. Feedback during the summer enrichment program, benchmark data will guide the instruction. Teachers will provide feedback to students and parents via phone calls, email, and documentation that is mailed home.

Briefly describe the district's summer learning, Extended School year (ESY) services, and enrichment programming (frequency, content areas, and duration, including days per week and number of weeks):

**K-2nd:** We plan to offer summer school the last three weeks of July, Monday-Thursday from 8:00 am - 12:00 pm. Kindergarten, first grade and second grade students who receive special education services in reading and/or math, were in intensive intervention for reading and/or math, and/or have a yearly average below 70 in reading, and/or math will be invited to attend. Teachers will plan lessons using power standards and gap learning plans to provide dynamic lessons on the most necessary learning targets.

**3rd-5th:** Summer school will be held 4 days a week for 4 hours each day (Monday-Thursday from 8:00-12:00). During that time frame, equal time will be given to the main subject areas (ELA and math). Students will be instructed with ELA and Math for 90 minutes each. The remaining 30 minutes is used for transitions and breaks. Summer school is held for 3 weeks.

**6th-8th:** The summer program will run the last three weeks of July. At this time, the program will run Mon.-Thur., 8:00-12:00. The curriculum is for ELA, math, social studies, and science. This is a remediation program for failing students, boarder-line students, SPED and Tier students.

**9th-12th:** The summer enrichment program will take place the last three weeks of July (July 13, 2020 to July 31, 2020). The hours will be 8:00am to 12:00pm daily. The summer enrichment program will include English and Math courses. The students that participate in the program will include those students that met ESY and those that were retained.

**ESY:** We will provide services to students this summer through extended School Year, this includes academic, as well as Speech.

Students will be monitored via iReady, Edgenuity and letters, phone calls and emails with parents. In the event students will be able to be in the buildings for the summer enrichment programs, their work in the classroom will be used to monitor participation.</b></p>
