Dear Mr. Clay:

The State Agency completed an Administrative Review of the National School Lunch Program (NSLP) and School Breakfast Program (SBP) during the week of April 9, 2018. The regulations governing the Administrative Review (7CFR 210.18) reference two Critical Areas of Performance: Performance Standard 1 and Performance Standard 2, as well as, several General Areas of Review. Findings were identified and are described below.

General Program Compliance

- The District is not utilizing a tracker tool for Professional Development. The SFA was not able to provide the following elements: 1. Date hired 2. Title/Position 3. Duties/Responsibilities 4. Employment Status 5. Professional Standards Category for each employee in the Child Nutrition Department (Regulation 7 CFR 210.30).

Performance Standard 2

- The SFA has elected to utilize the State Agency's recipes "Mississippi Recipes for Success" even though the SFA is not following the recipes as written. Federal Regulations require all organizations to follow standardized recipes (Regulation 7 CFR 210.10).

We provided technical assistance (TA) in several areas to the Child Nutrition Director. These comments are located in the Mississippi Application and Reimbursement System (MARS), in the comments section of the On-site Assessment Tool. These comments are provided for the improvement of the program operations.

A corrective action response to the findings of this review is due by May 31, 2018.
