Dear Dr. Towner:

The State Agency completed an Administrative Review of the National School Lunch Program (NSLP) and School Breakfast Program (SBP) during the week of May 15-18, 2018. The regulations governing the Administrative Review (7CFR 210.18) reference two Critical Areas of performance: Performance Standard 1 and Performance Standard 2, as well as several General Areas of Review. While findings were identified, there were findings related to the two performance standards. The findings are described below.

**Meal Pattern and Nutritional Quality**

- There was only one 1/2 cup fruit available at breakfast meal service (CFR 220.8)
- The 9-12 Lunch Nutritional Analysis sodium requirement exceeded during the review week (7 CFR 210.10 (f)).


We provided technical assistance (TA) in several areas to the Child Nutrition Director.
