Dear Mr. Jones:

The State Agency completed an Administrative Review of the National School Lunch Program (NSLP), School Breakfast Program (SBP) and Afterschool Care Program (ASCP) during the week of October 29, 2018. The regulations governing the Administrative Review (7 CFR 210.18) reference two Critical Areas of performance: Performance Standard 1 and Performance Standard 2, as well as several General Areas of Review. While findings were identified, there were no findings related to the two performance standards. Findings that were identified are described below.

General Program Compliance

- The vending machines and the school store were not in compliance with the Smart Snack regulatory requirements of products sold to students during the school day as outlined in 7 CFR 210.11.
- The Competitive Food rule states that no food items will be sold on the school campus for one (1) hour before the start of any meal services period per the MS State Board Policy rule 17.2. Waynesboro Central School was not in compliance,

We provided technical assistance (TA) in several areas to the Child Nutrition Director. These comments are located in the Mississippi Application and Reimbursement System (MARS), in the comments section of the On-site Assessment Tool. These comments are provided for the improvement of program operations.

The SFA must send written notification and supporting documentation to the SA certifying that it has completed the corrective action required for each finding, as well as corresponding dates of completion.

A corrective action response to the findings of this review is due by December 12, 2018 and must be entered in MARS by the Child Nutrition Director.


