

- House Bill 4130 passed during the 2024 Regular Legislative Session created the new Mississippi Student Funding Formula (MSFF).
- MSFF replaces the previous funding formula, Mississippi Adequate Education Program (MAEP).
- The formula includes a base student cost formula, an inflation factor, and weights for low income, poverty, English Language Learners, Career and Technical Education, Special Education, and Gifted students.
- The formula provides an additional \$218M in education funding.
- The Mississippi Department of Education (MDE) will work with the Legislature to provide a report on the formula prior to the 2025 Regular Legislative Session.
- The revenue function for this revenue is 3150.



- Senate Bill 2695, Driver's Education, passed during the 2024 Regular Legislative Session amended MS Code Section 37-25-3.
- Beginning in the 2026-2027 school year the school board of any school district maintaining a secondary school shall establish and maintain driver education and training programs for students enrolled in the secondary schools in that district.
- The program shall include both classroom and behind-the-wheel instruction.
- The MDE and the Commissioner of Public Safety shall jointly prepare an estimated budget and fiscal report of the additional expenses and costs related to the implementation of mandatory driver education programs and present to the legislature prior to the 2025 Regular Legislative Session.



- House Bill 1823 passed during the 2024 Regular Legislative Session appropriated funding for the increases in PERS and Health Insurance in a separate line item.
- The revenue function assigned is 3280. No fund numbers will be assigned.
- School payments for funding will be made to each school district on July 29, 2024, for the full amount allocated to each district for FY2025.
- In FY2026 funding for the FY2025 PERS and Health Insurance increases will roll into the MSFF as an adjustment to the Base Student Cost.



- Total funding per the FY2025 MSFF allocation notices are compared to funding for FY2024 MAEP, FY2023 Teachers & Asst. Teacher Pay Raise funding provided in FY2024 and Average Daily Enrollment (\$100M).
- For FY2025 there are **no** separate funding allocations for the FY2023 Teacher & Asst. Teacher Pay Raise, and Average Daily Enrollment (\$100M).
- For FY2025 the School Recognition Program was not funded.



- FY2025 state funding to school districts includes:
 - MSFF (Revenue Function 3150)
 - Master Teacher Certification (Revenue Function 3291)
 - EEF Bldgs. & Buses (Revenue Function 3210)
 - Chickasaw Cessions (Revenue Function 3130)



- FY2025 PERS Employer Increase is 1/2 percent effective July 1, 2024:
 - ➢ FY24 Rate 17.40%
 - ➢ FY25 Rate 17.90%
- FY2025 Health Insurance monthly base premium for employees effective January 1, 2024, was \$459.
- The monthly base premium for employees effective January 1, 2025, has not been released.
- The FY2025 MSFF includes funding for the health insurance increase for January 2024 December 2024.
- Any increases for January 2025 will be included in the FY2026 MSFF Final calculation, January 2025 – December 2025.

Education Enhancement Funds – EEF Procurement Card



- The FY2025 allocation amount for each eligible teacher and necessary support staff is \$740.
- The number of cards requested by districts for the first order total 37,112.
- A second and final request for cards needed by the districts will be done in August 2024.
- The cards will begin shipping on Monday, July 15, 2024.
- The cards should be distributed to eligible personnel by Thursday, August 01, 2024.



FY2025 EEF Procurement Card Updates (continued)

- FY2025 EEF Procurement Card provider is U. S. Bank.
- All districts will receive plastic cards.
- Cards will be issued with an expiration date of four years.
- Cards will be identified with supply account numbers as previous years. The teacher's name will not be included on the card.
- There is no need to reorder cards for all eligible personnel each year after FY2025. Cards only need to be ordered for new hires eligible to receive a card.
- All cards for the State of Mississippi will be activated, tentatively Wednesday, July 31, 2024.



- The district is no longer required to send an email to the OSFS notifying us that the district is ready to activate the cards.
- Cardholders may also activate their card by calling the customer service phone number located on the back of the card.
- The cardholder may be asked one of the following when activating the card:
 - Social Security Number this will be the district four-digit ID Number
 - >ID Code assigned for the agency **999999359**
 - >Organizational Short Name MDEEEF
 - Business Phone Number this is the phone number the district provided per the cardholder enrollment form submitted to the OSFS.



- Once the cardholder activates the card the cardholder may register the card online, setup user id, and password.
- It is important that staff remember password when setting up account. After three failed attempts the cardholder will be locked out.
- A request must be sent to the district program coordinator to reset the password.



- If cardholder chooses to use a vendor that is blocked, an email must be sent to the OSFS <u>financialservices@mdek12.org</u> requesting the vendor be approved for purchasing.
- Please provide information regarding what is being purchased and how it relates to instruction.
- Cards will be deactivated at 12:00a.m., Tuesday, April 01, 2025. Please encourage cardholders to expend funds quickly.




- Trainings for the district program coordinator are scheduled for Wednesday, July 17, 2024, and Wednesday, July 31, 2024.

- A training invite was sent via the business manager listserv on Wednesday, June 26, 2024, to all business managers.
- The business managers were informed to forward the training invite to the district program coordinator.



- U.S. Bank begin sending emails regarding the Commercial Card applications to districts last week for the purchasing and travel card programs administered by the Department of Finance and Administration.
- Information per application will be used to provide rebates to the school districts for these program.

Paymode User Fees

- Paymode has charged several districts a network user fee of 1.5% for each deposit received. Please review the districts May and June 2024 bank statements.
- Paymode states this is due to an updated relationship with the State of Mississippi in Paymode-X.
- The MDE has worked with school districts and Paymode-X to have fees approved for reimbursement processing for two of four districts.
- The fees charged for the two districts together total \$116K.

- The assessed valuation of real, personal (including automobiles), and public service valuation is requested from the local taxing authority in December of each year.
- The assessment information for the Special Homestead Valuation and Homestead Credit allowed are obtained from the Department of Revenue.
- The information is due to the OSFS before February 1 of the year following the request (MS Code Section 37-151-211 (1)(a)).



- The levying authority for the school district shall levy a tax of not less than 28 mills or a millage rate equivalent to twenty-seven (27%) of the MSFF calculation, whichever is less (MS Code Section 37-151-2 (2)).
- The information provided is used in the MSFF calculation in determining the local contribution that each school district or charter school is required to provide toward the cost of local contribution funding.



Mississippi Student Funding Formula (MSFF): Hold Harmless

- The state share in support of the funding formula for fiscal years 2025, 2026, and 2027.
- Funding for these years may not be less than **all** state funds received for FY2024.
- All state funds for FY2024 includes funding for FY2024 MAEP, FY2023 Teacher & Asst. Teacher
 Pay Raise funding received in FY2024, and Average Daily Enrollment (\$100M).
- FY2028 the hold harmless provision will no longer apply to funding levels.

- For FY2025 twenty-eight (28) districts (including charter schools) received Hold Harmless funding.
- Hold Harmless funding ranged from \$25K \$2.6M, total \$17M.
- For the FY26 MSFF Preliminary calculation there were a total of twenty-five (25) districts (including charter schools) estimated to receive Hold Harmless funding.
- Hold Harmless funding range from \$34K \$1.5, total \$12M.



 For FY2026 the Base Student Cost will increase by an amount equal to 25% of the base student cost for the previous year, multiplied by the twenty-year average annual change in the rate of inflation for the State of MS as determined by the State Economist, plus any adjustments for additional state requirements.
